Important Dates	Events
23-07-2026 (Thursday)	Display of B.Ed. Colleges participating in B.Ed. Counselling with stream-wise intake.
27-07-2026 (Monday)	Cut-off Score: 70 and above. Students from all categories who have scored 70 or above in B.Ed. Entrance-2026 are eligible to attend the offline counselling session.
28-07-2026 (Tuesday)	Cut-off Score: 63 to 69. Students from all categories who have scored 63 to 69 in B.Ed. Entrance-2026 are eligible to attend the offline counselling session.
29-07-2026 (Wednesday)	Cut-off Score: 58 to 62. Students from all categories who have scored 58 to 62 in B.Ed. Entrance-2026 are eligible to attend the offline counselling session.
30-07-2026 (Thursday)	Cut-off Score: 53 to 57. Students from all categories who have scored 53 to 57 in B.Ed. Entrance-2026 are eligible to attend the offline counselling session.
31-07-2026 (Friday)	Cut-off Score: 53 and above. This is only for students who missed the first round of offline counselling.

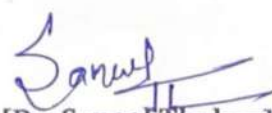
